Dr. Ronald J. Neimkin is a Paradigm Medical Director, specializing in orthopedics and pain management. He is an adjunct clinical professor of orthopedic and hand surgery at Wake Forest University School of Medicine.

Dr. Neimkin graduated from Rutgers University in 1971, and attended Jefferson Medical College and Cornell University Medical College, where he earned his MD in 1975. He was a resident in general surgery at Roosevelt Hospital and in orthopedic surgery at Duke University Medical Center, where he served on the replant and spinal trauma teams. He received his North Carolina medical license in 1977.

Dr. Neimkin served as instructor of anatomy at Duke University School of Allied Health and as a Cannon Fellow at Cabarrus Memorial Hospital in Concord, NC. He then did pediatric orthopedics at Shriner's Hospital in Greenville, South Carolina. He completed a hand surgery fellowship at Massachusetts General Hospital and Harvard-affiliated hospitals, and then he went on to complete a foot surgery fellowship at the Duke University Medical Center. He was certified by the American Board of Orthopaedic Surgery in 1983, with added qualification in surgery of the hand in 1989. From 1982 to 1986, Dr. Neimkin was assistant professor of orthopaedics at the University of Alabama School of Medicine, and from 1986 to 2011, assistant consulting professor of orthopaedic surgery at Duke University Medical Center.

He has served in private practice at Stein Orthopaedics; the offices of Dr. Harry Bade; Asheville Orthopaedic Associates; and Carolina Hand Association, where he was a founding partner. Since 2011, he has been in private practice in orthopedics.

A Fellow of the American College of Surgeons, Dr. Neimkin is widely published; his articles have appeared in *Journal of Hand Surgery, Orthopedics*, and *Southern Medical Journal*. He has lectured on topics from carpal tunnel syndrome to rehabilitation after hand injuries, and has served as a medical volunteer in Haiti.

Dr. Neimkin has been with Paradigm since 2015, focusing on orthopedic hand surgery and complex pain cases.
